Dated Dispur, the 6<sup>th</sup> September, 2003.

In continuation of this Deptt. O.M. NO.PPG.(P)196/92/35 dated 12-9-96, it is reiterated that said O.M. clearly lays down that a Govt. Servant rendering 20 years of continuous Service without being confirmed shall be eligible for pensionary benefits. The focus is on 20 years of continuous service. After rendering 20 years of Service if the Govt. servant is superannuated or incapacitated or dead is not\*\* root point. Any confusion in this regard is against the spirit of the O.M. referred to above.

It is therefore, clarified that pensionary benefit as contemplated in the above O.M. shall be admissible to a Govt. Servant who died after rendering 20 years of Continuous Service. Other terms and conditions for eligibility of Pension shall remain same as usual.
