**SUB : COUNTING OF PAST SERVICES OF MUSTER ROLL WORKERS
TOWARDS PENSION / D.C.R.G.**

In continuation of this Department's OM No. PPG(P) 88/2009/2 dated 20/05/2009 and OM No.PPG(P) 83/89/1 dated 14/12/1989, the Governor of Assam after careful observation is pleased further to pass the following orders / clarification.

- i. In case of the Muster Roll Workers whose services have been regularized as Work Charged at a later stage of service life, only 3 (three) years of initial period of service shall be deducted while reckoning the qualifying service for pension / DCRG, etc.
- ii. The other conditions of Muster Roll service already laid down in the above referred OM's will remain the same.

The Assam Services (Pension) Rules, 1969, Assam Financial Rules and Assam P.W.D. Code stand amended to the extent of the order contained herein. Formal amendments will be issued in due course.

This issues with the concurrence of Finance (EC-II) Department vide their U/O No. FEC(II) 738/2017, dated 29/03/2017.
