The undersigned is directed to refer to para 8.2 of the Finance Deptt.'s O.M. No.F.M.58/81/24 dtd. 25.2.83 and to enclose tables showing the actual benefits from the savings fund under the State Govt. Employees Group Insurance Scheme, 1983 for the period from 1.4.2001 to 31.3.2002 on monthly subscription of Rs. 15.00 in modification of the table circulated vide this Deptt.'s OM.NO.PPG(P)126/89/pt/58, dtd. 12.6.2001 and NO.PPG(P) 126/89/pt/60 dtd. 12.12.2000. The amount shown in the enclosed table have been worked out to the nearest Rupee after taking into account interest up to end of the month of cessation of membership and it has been assumed that the subscription for any month including the month of cessation of membership has been or will be deducted from that month salary paid or to be paid at the end of the month. The respective benefit from the savings fund of a monthly subscription of Rs. 30, Rs.60 and Rs.120/- P.M.will be twice, four and eight times of those of a monthly subscription of Rs. 15/-.
