


OFFICE MEMORANDUM

Subject: State Government Employees Group Insurance Scheme, 1983

The undersigned is directed to refer to the Para 8.2 of the Finance Department's OM No. FM.58/81/24, dated 25/02/83 and to enclose tables showing the actual benefits from the savings fund under the State Government Employees Group Insurance Scheme, 1983 for the period from 01-04-2008 to 31-3-2009 of monthly subscription of Rs.15/- in continuation of the table circulated vide this Department's OM No.PPG (P) 126/89/Pt/118 dtd.19/5/2007.

The amount shown in the enclosed table have been worked out to the nearest rupee after taking into account interest up to the end of the month of cessation of membership and it has been assumed that the subscription for any month including the month of cessation of membership has been or will be deducted from that month salary paid or to be paid at the end of the month. The respective benefits from the savings fund of a monthly subscription of Rs.30/-, Rs.60/- and Rs.120/- PM will be two, four and eight times of those of a monthly subscription of Rs.15/-
