Sub : Clarification to Caluse (4) and (9) of OM No. PPG(P) 140/2017/9, dated 12/07/2017 and  
Clause (12) of OM No. PPG(P) 140/2017/10, dated 12/07/2017.

Sir,

With reference to the subject cited above, I am directed to say that P & PG Department has received complaints from some of the implementing authorities and from pensioners regarding implementation of Clause (4) and (9) of OM No. PPG(P) 140/2017/9, dated 12/07/2017 and Clause (12) of OM No. PPG(P) 140/2017/10, dated 12/07/2017.

In view of the complaints received, and in order to mitigate the confusions, the following clarifications are issued as below :-

**Clarification to Clause (4)**

**Additional quantum of Pension :**

All pensioners who have attained 80 years of age or more as on 01/04/2016 ; their pension shall be increased by 20% calculated on the basic pension drawn by the pensioner on 01/04/2016. The effective date for allowing the benefits of additional quantum of pension shall be 01/04/2016 and any arrear accrued w.e.f. 01/04/2016 shall be paid to the eligible pensioners.

**Clarification to Clause (9)**


**Payment of Arrear :**

Under Clause (9) of OM No. PPG(P) 140/2017/9, dated 12/07/2017 and Clause (12) of OM No. PPG(P) 140/2017/10, dated 12/07/2017, the "balance arrear" indicates any arrear accrued for the period mentioned in Finance Deptt's Notification No.FPC.9/2017/4, dated 19/09/2017 including the period w.e.f. 01/04/2017 to till the issuance of P & PG Deptt's OMs dated 12/07/2017. The same shall be paid to the eligible pensioners accordingly.

No separate order shall be issued in this regard.

You are therefore requested to take appropriate action accordingly.


