OFFICE MEMORANDUM

The 19the November, 1998

Subject: Revision of Pension of pre 1at January, 1996 Pensioners/Family Pensioners etc. implementations of Government decisions on the recommendations of the Assam Pay Commission, 1994.

No. PPG.(P)164/98/66.-The undersigned is directed to say that in pursuance of the Government decisions on the recommendations of the Assam Pay Commission announced under Government Resolution No. FPC.5/94/169, dated the 4th July, 1998 as published in the Extra-Oedinary issue No. 134 of the Assam Gazette dated the 4th July, 1998 sanction of the Governor of Assam is hereby accorded to the regulation/revision of pension/family pension with effect from 1st January, 1996 of all the pre 1st January, 1996 pensioners/family pensioners in the manner indicated herein the succeeding paragraphs.



- These orders apply to all pensioners/family pensioners who were drawing pension/family pension on 1st January, 1996 under the Assam Services (Pension) Rules, 1969.
- 3. In these orders, the following terms are used in the sense explained herein below:
- (a) 'Pay' the term pay means the basic pay in revised scale promulgated under the Assam Services (Revision of Pay) Rules, 1998.
 - (b) 'Basic Pay' means pay as defined in Assam fundamental Rule 9 (21) (a) (i).
- (c) 'Emoluments' means basic pay as defined in F. R. 9 (21) (a) (i) of the State F.R's, and S.R's which the Government employee was receiving immediately before his retirement or on the date of death for the purpose of calculation of pension. Similarly, "Average emoluments" shall be determined with reference to basic pay as defined under F.R. 9 (21) (a) (i) drawn by a Government employee during the last 10 (ten) months of his service. 'Emoluments' for the purpose of calculation of all kinds of gratuities (retirement, death, service, terminal) will include the Dearness Allowanace on the date of retirement.
- (d) "Existing pensioner/family pensioner" means a pensioner/family pensioner who was drawing entitled to pension/family pension on 31st December, 1995.
- (e) "Existing pension" means the basic pension inclusive of commuted portion if any, due on 31st December 1995. It covers all classes of pension under the Assam services (Pension) Rules, 1969.
- (f) "Existing Family Pension" means the basic family pension drawn/entitled on 31st December 1995 under the Assam Services (Pension) Rules, 1969.
- (g) "Existing Dearness Relief" means the relief due to pensioners/family pensioners upto average C.P.I 1510 i.e. @ 95%, 71% and 62% of basic pension/family pension as admissible under this Deptts.'s O.M. No.PPG (P) 12/95/56, dated 9th March 1996.
- 4.1. The pension/family pension of existing pensioners/ family pensioners i.e. (pre 1st January, 1996 pensioners/family pensioners) shall be consolidated/revised with effect from 1st January 1996 by adding together:-
 - (i) the existing pension/family pension as on 31st December 1995.
 - (ii) the Dearness Relief upto C.P.1. 1510 i.e. @ 95%, 71% and 62% of basic pension as admissible under this Deptt.'s OM No.PPG (P) 12/95/56,dated 19th March 1996.
 - (iii) the first instalment of Interim Relief of Rs. 50.00 sanctioned under OM No.FPC.14/94/21, dated 21st February 1995.
 - (iv) the second instalment of Interim Relief @ 10% of basic pension/family pension as sanctioned under OM No.FPC.14/94/79, dated 24th January 1996 subject to a minimum of Rs. 50.00 and maximum of Rs. 125.00 P.M.
 - (v) fixation benefit @ 25% of the existing basic pension/family pension.

The above computation is subject to the following conditions:-

- (i) pension for the purpose of this calculation will include commuted portion of pension also.
- (ii) for payment of pension after re-fixation, the commuted portion of pension will be excluded.
- (iii) no fresh commutation/DCRG will be permissible over this revised pension. The amount so computed on the basis of the above principles will be 'Basic Pension' for all purposes with effect from 1st January 1996 onwards.

- 4.2. The amount so arrived at will be regarded as revised pension/family pension with effect from 1st January 1996. The upper ceiling on pension/family pension laid down under this Deptt's. C. No.PPG (P) 136/90/239, dated 2nd April 1991 has been increased from Rs.3150/- and Rs.900/- to 50% and 30% respectively of the highest revised pay in the State Government. (The highest revised pay in the State Government is Rs.17,000/-). Since the revised/consolidated pension will be inclusive of commuted portion of pension, if any, the commuted portion will be deducted from the said amount while making monthly disbursement.
- 4.3. Since the revised/consolidated pension/family pension arrived at as per the paragraph 4.1 above includes Dearness Relief upto the CP1 1510, the Dearness Relief will be admissible thereon only beyond index average CP1 1510 in accordance with the revised scheme of Dearness Relief. The three instalments of Dearness Relief sanctioned earlier from 1st July 1996, 1st january 1997 and 1st July, 1997 under this Deptt's. OM No.PPG (P) 12/95/79, dated 4th January 1997, No.PPG(P) 12/95/87, dated 26th June 1997 and No.PPG (P) 12/95/102, dated 17th December 1997 respectively as the increased difference over the Dearness Relief sanctioned in OM No.PPG (P) 12/95/56, dated 19th March 1996 shall be adjusted against revised Dearness Relief becoming due on the revised consolidated pension/family pension.
- 4.4 The amount already paid on account of 3rd I.R. sanctioned under OM FPC.14/94/155, dated 5th May 1997 for the pensioners will no longer be admissible with effect from 1st December 1998 and this I. R. drawn till 30th November 1998 will be adjusted from the arrears payable due to the revision/consolidated pension/family pension as in para 4.1. above and sanctioned of Dearness Relief on revised/consolidated pension/family pension.
- 5. Where the revised/consolidated pension/family pension in terms of paragraph 4.1. above works out to an amount less than Rs. 1,225/-the same shall be stepped upto Rs. 1,225/-. This will be regarded as pension/family pension with effect from 1st January 1996. In case of pensioners who are in receipt of more than one pension the floor ceiling of Rs. 1225/- shall apply to the total of all pensions taken together.
- 6. Pension: The amount of pension of the Government employees who were retiring from service on of after 31st January 1996 shall be determined @ 50% of last 10 months average emoluments with a qualifying service of 33 years or more. For Government employee who at the time of retirement have rendered qualifying service of 10 years or more but less than 33 years, the amount of pension will be proportionately less then the maximum admissible pension. The minimum pension will be Rs.1,225/- and the maximum pension Rs.8,500/-. Similarly pension of Government employee who retire under F.R. 56 and family pension in case of death between 1st Jnuary, 1996 to 31st January, 1996 shall be determined at the procedure as aforesaid.
- 6.1. (a) A Government servant who die while in service after having rendered not less than 7 years continuous service the rate of family pension payable to the family shall be equal to 50% of the pay last drawn or twice the family pension admissible under the normal rules, whichever is less, and the amount so admissible shall be payable from the date following the date of death of the Government servant for a period of 7 years, or for a period upto the date on which the deceased Government servant would have attained the age of 65 years, had he survived, which is less.
- (b) Further, in the event of death of a Government servant after retirement the family pension at the rate stipulated under (a) above shall be payable for a period of 7 years or for a period upto the date on which the retired deceased Government servant would have attained the age of 65 years had he survived, whichever is less.

- 7.1. In case Government employee who have opted for the revised scale of pay and retire within 10 months from the date of coming over to the scale of pay the average pay for 10 months period preceding retirement shall be calculated by taking into pay as follows:
- (i) For the period during which pay is drawn in pre-revised scale "basic pay" plus Dearness Allownace as admissible as on 1st January, 1996. Interim Relief appropriate with basic pay at the rates in force on 31st December, 1995 drawn during the relevant period, and
 - (ii) for the period during which pay is drawn in revised basic pay in the revised scale.
- 7.2. Family Pension: The rate of family pension stood revised at the rate of 30% of last basic pay. This rate will be applicable to all categories of pensioners with effect from 1st January, 1996.
- 7.3. <u>Updating of Family Pension</u>: In case of existing pensioner in whose case the family pension has not come into operation as pensioners are/were alive on 1st January, 1996 the rates of family pension at enhanced rate and at normal rates noted on their pension payment order will be updated in terms of these orders. The updated rates of family pension will apply as and when family pension becomes payable in such cases.
- 8. **Dearness Relief to pensioners**: The rates at which dearness relief will be admissible to the State Government pensioners including holders of Family pension and Extra-ordinary pensioners are indicated below:-

Period from which payable

Rate of Dearness Relief

1. From 1.1.96	NIL
2. From 1.7.96	4% of Basic pension/Family pension
3. From 1.1.97	8% of Basic pension/Family pension
4. From 1.7.97	13% of Basic pension/Family pension.

Table showing Dearness Relief admissible on the Revised pension/Family pension is being issued separately.

- 8.1. The rates of Medical Relief (Allowance) payable to pensioners/Family pensioners stood revised @Rs. 250.00 P.M. w.e.f. 01.08.98 onwards.
- 9. <u>Death-cum-Retirement Gratuity</u>: The existing maximum of D.C.R.G. has been raised from Rs. 72,000.00 to Rs. 2 lakhs without any change in other conditions as at present. This benefit will be applicable to the Government employees dying/retiring on or after 1st January, 1996.
- 10. Service Gratuity: Service gratuity to persons retiring with less than 10 years of service will continue to be admissible as per existing rules. However, the service gratuity will be calculated at an uniform rate of half months basic pay as defined in F.R. 9 (21) (a) (i) for each completed six monthly period of qualifying service. This will be applicable to Government servants retiring on or after 1st January, 1996.
- 11. All pension disbursing authorities including the selected public sector Banks handling disbursements of pension/family pension to the Government pensioners/family pensioners are hereby authorised to pay pension/family pension to existing pensioners/family pensioners at the revised/consolidated rates without any further authorisation from the Accountant General, (A&E), Assam. A table indicating the revised/consolidated pension/family pension w.e.f. 1.1.96 is enclosed

For ready reference at ANNEXURE-I. A suitable entry regarding the revised/consolidated pension shall be recorded by the Pension Disbursing Authorities in both halves of pension payment order. An intimation regarding disbursement of revised pension may be sent in the prescribed form at ANNEXURE-II by the Pension Disbursing Authorities to the Office of the Accountant General (A&E), Assam which had issued the pension payment order in the form given at Annexure-II. So that the later can update the Pension Payment Order Register maintained by his office. An acknowledgement shall be obtained by the Pension Disbursing Authorities from the Office of the Accountant General (A&E), Assam.

- 11.2 A consent letter for realization of excess drawal, I any, on account of refixaion of pension and family pension may be obtained as per form at ANNEXURE-III from the pension and family pension holder.
- 12. The revised/consolidated pension/family pension as computed in accordance with the provisions of paragraphs 4.1 above shall be treated as final "Basic Pension/Basic Family Pension" with effect from 1st January, 1996 and shall qualify for the grant of dearness relief sanctioned thereafter in respect of the following categories of pensioners/family pensioners:-
 - (a) Pensioners who retired between the period from 1st January, 1989 to 31st December, 1995.
- (b) Family pensioners who become entitled to family pension during the period from 1st January,1989 to 31st December,1995 and were sanctioned the family pension @ 30% of the last pay drawn by the deceased Government employee.
- 13. In case of other pensioners/family pensioners who retired before 1st January,1989 or who were in receipt of pension/family pension before 1st January,1989 these orders provide for revision/consolidation of pension with effect from 1st January, 1996 as an interim measures only so as to provide them immediate relief and shall be subject to variation. Detailed orders/instructions regarding fixation of their pay on national basis and revision/consolidation of their pension/family pension and issue of authorization in this regard will be issued separately. Pending issue of detailed instruction as stated above, the grant of pension/family pension of all these pensioners/family pensioners may be continued to be regulated under these orders.
- 14. The arrears, if any, in respect of persons who retired or will retire from Government service during the period from the 31st January,1996 till 31st December,1998, their arrears arising out of the revision of pay and allowances will be paid in cash after adjustment of Interim Relief drawn under OM No. FPC.14/94/145, dated 1st February, 1997 and OM No.FPC.14/94/155, dated 5th May, 1997.
- 15. Expenditure on account or revised/consolidation of pension/family pension, revised rates of Dearness Relief and Medical Relief shall be debitable to the budget head to which pension, etc. are debited.

Formal amendment to Assam Services (Pension) Rules,1969 in terms of the decision contained in this OM will be issued in due course.
