No. CDNE/8/2019/5.- Whereas the Dhalpukhuri BMSS Ltd. (Hojai) registered with Registration No. H-39/1992-93 dated - 30th July, 1992 ceased to function for long and even after issuance of necessary notice giving an opportunity to revive the society, members have not taken any initiatives for its revival.

Whereas the inspection report caused under Section 88(I) of the Assam Co-operative Act, 2007/ (As amended up-to-date) reveals that there is no scope for its revival.

Now, I Sri B. Chakravarty, Dist. Deputy Registrar of Cooperative Societies, Nagaon is of opinion that the registration of the said society requires to be cancelled.
