**No. PPG(P) 418/2021/24.-** In pursuance of the approval of Hon'ble Cabinet held on 28th October, 2021 for streamlining the procedures for reducing the hardship faced by the Pensioners and in order to simplify the procedure for medical examination of the retirees applying for Commutation of Pension after one year of retirement, Health & Family Welfare Department, Government of Assam will authorize 5(Five) Medical Boards of the Medical Colleges of the State of Assam apart from MMC, SMC and AMC as Competent Board for medical examination of the retirees applying for Commutation of Pension after one year of retirement with immediate effect.

**No. PPG(P) 418/2021/20.-** In pursuance of the approval of Hon'ble Cabinet held on 28th October, 2021 for streamlining the procedures for reducing the hardship faced by the Pensioners and in order to simplify the procedure for waiver of excess drawal, Finance Department, Government of Assam will authorize the Director of Pension for waiver of excess drawal up to the amount of Rs. 3 Lakh (Rupees Three Lakh) exclusively for the Pensioners of Provincialised Schools and PRIs with immediate effect.

**No. BB.20/2021/29.-** In pursuance of the approval of the competent authority, the Government Guarantee (GG) against loans taken by Assam Infrastructure Financing Authority (AIFA) under Nabard Infrastructure Development Assistance (NIDA) to the tune of 10,000 Cr (INR) is granted alongwith exemption from payment of guarantee fee on Government Guarantee.
