

Sub : **Applicability of the State Govt. Employees Group Insurance Scheme 1983 to the new entrants in the Government Service on or after 1<sup>st</sup> Feb., 2005.**

As per New Defined Contribution Pension Scheme effective from 01-02-2005 State Government employees entering service on or after 01-02-2005 are not eligible to open GPF Account. They are however required to subscribe compulsorily to the State Government employees Group Insurance Scheme, 1983.

This is issued in pursuance to the Finance (Budget) Department's letter No.BW.7/2008/292 dated 26-05-2009.


